Greetings New Mexico Colleagues:

First, thank you for nominating and supporting me as New Mexico ACEP President for this year. I am very excited to serve in this role and honored to be able to represent our chapter on the national stage.

We find ourselves in an unprecedented time in the world, with novel coronavirus fundamentally disrupting the way we conduct our lives and work. Within this context, Emergency Medicine clinicians face challenges never before experienced -- gripping concern regarding the wellbeing of our patients and communities, learning minute-by-minute how to best treat Covid-19, facing PPE shortages while coping with anxiety about personal and family safety, "working from home" without the support of daycare and school, and operational challenges related to the delivery of Emergency Medicine. Recently we have been wondering - "where did all the patients go," with concerns that our fellow New Mexicans may be sitting at home, avoiding seeking life-saving care due to concerns of either becoming infected by Covid-19 or trying to adhere to a public health message to only seek care if truly emergent. We are now seeing a return in our ED volumes in the Albuquerque-area in both the medical and psychiatric emergency departments – and are unsure if the future holds a dramatic rise in need or continued avoidance due to loss of insurance, a downturn in the economy, and fear of Covid-19. <u>Read More</u>
